# 2018 EPESaver Residential Insulation Rebate Program

Improve Your Comfort. Save Energy.

## CHECKLIST

Incomplete rebate forms will **NOT** be accepted. Did you:

- Include a copy of your dated receipt or contractor invoice that details all installed insulation including square footage?
- Include your EPE account number?
- Complete all customer and installed equipment information?
- Sign and date the application?
- Include contractor contact information (if applicable)?
- Include pre and post installation photos?
- Include the pre and post R-Value?

**Did you know that heating and cooling account for the majority of your monthly energy bill?** If your household isn't properly insulated, chances are much of that cold and warm air is escaping and taking your money with it.

The EPESaver Residential Insulation Rebate Program can help you reduce energy spending and use by improving the energy efficiency of your homes. The Program provides cash incentives for insulation improvements in your ceiling and floors. Rebates are calculated according to the level of insulation improvements that you make.

**Note:** New construction projects are **NOT** eligible to receive rebate. Home **MUST** be cooled with refrigerated air conditioning to qualify for rebate. Homes with evaporative cooling may qualify if heated with electric resistance heating. Please call Energy Efficiency directly at (575) 523-3533 for eligibility requirements.

## The Knowledge You Need.

Insulation levels are measured by R-Value. Simply put, the higher the R-value, the higher the level of insulation. Rebates are calculated according to the difference between your existing R-Values and minimum levels required by the program.

### Required Improvements

Insulation Type	Must Reach
Attic Insulation	R-30
Floor Insulation	R-19

### Required Existing Conditions

Insulation Type	Must Reach
Attic Insulation	R-22 or Lower
Floor Insulation	No Existing Insulation

To calculate your existing R-value use a ruler to measure the thickness of your existing insulation. Use an R-value of 3 for each inch of existing insulation. So if you have 4 inches of insulation, your starting R-value is R-12. (4 inches x R-3 per inch = R-12)

## Participation Made Easy.

1. Select a contractor of your choice.
2. Customers may also elect to pursue an EPESaver Insulation rebate without the help of a contractor.
3. Once new insulation has been installed, the EPESaver Insulation rebate form may be completed online or mailed along with a copy of your receipt or invoice to the rebate processing center address. Additional rebate forms can be downloaded from the EPESaver website at [www.epesaver.com](http://www.epesaver.com).
4. Your rebate will be mailed directly to you from EPE. Rebate checks will be mailed within 4–6 weeks of receiving the rebate form.

**Rebates are issued on a first come, first served basis until funding is exhausted or the program is changed. All rebates are subject to approval by EPE's Program Manager.**

**Rebate Calculation Example:** An electric-heated house with refrigerated air conditioning that has 1,500 square feet of 1 inch of existing ceiling insulation is upgraded to R-30. The starting R-value is R-3 ( 1 inch x R-3 per inch = R-3) using the Incentive Schedule for Ceiling Insulation below, the rebate is \$0.50 per square foot or \$750 (1500 square feet x \$0.50).

### Incentive Schedule for Floor Insulation

Heat Type*	Site Built Home (\$/SqFt)	Manufactured Home (\$/SqFt)
Electric Resistance	\$0.30	\$0.26
Heat Pump	\$0.10	\$0.10

\* Gas heated homes are not eligible to receive a rebate for floor insulation.

### Incentive Schedule for Ceiling Insulation

Starting R-Values	Gas (\$/SqFt)	Electric Resistance (\$/SqFt)	Heat Pump (\$/SqFt)
R-0	\$0.10	\$1.05	\$0.61
R-1 to R-4	\$0.07	\$0.55	\$0.32
R-5 to R-8	\$0.03	\$0.35	\$0.20
R-9 to R-14	\$0.03	\$0.17	\$0.09
R-15 to R-22	\$0.01	\$0.06	\$0.03
